



Animal Services officers investigate animal related calls. Services include animal bite reports, animal welfare and cruelty checks, rabies control, stray animals, and emergency response for sick and injured stray animals. Officers also enforce all State of Illinois and local animal ordinances in Winnebago County, helping to keep pets and people safer.



### Activity Calls by Municipality - 2024

Out of the over 7,900 activity calls that our Animal Services officers responded to, 65.91% of those calls were within the City of Rockford. Subsequently, 14.92% of those calls were to Winnebago County, 5.52% were in Machesney Park, and 6.58% to Loves Park.






### **Officer Activity**

In 2024, Animal Services Officers handled over 7,900 calls. 37% of the calls were for a stray domestic animal, usually a dog running loose. Investigation for welfare, a bite, or barking made up 33% of calls. "Other" calls included other investigations (e.g. running at large, rabies vaccination/registration, animal fighting) and assisting other agencies (e.g. police, fire departments) or assisting animal owners.



#### **Field Service Outcomes**


Officers responded to 7,989 calls in 2024. There are more outcomes than calls because more than one outcome was recorded for some calls. For example, if an officer impounded a stray dog and left a written warning for the owner, both outcomes were recorded for the call. The most common outcomes are listed below (except for citations, which are described in the following section). Warnings include both verbal and written. Other outcomes not specifically listed include: made contact, no service needed, unable to catch animal, owner or complainant not home, wild animal relocated, trap set/checked/picked up, and full compliance.

### **Citations Issued**

Officers issued 895 citations in 2024, both in the field and at the shelter. Of those, 192 were for rabies vaccination/registration or Code Hearing Unit "Notice of Animal Violation." The other 703 were "Notice to Appear" citations. The majority of those citations were for a dog running at large (392). Animal Welfare (196) includes Owner's Duties, Animal Cruelty, Aggravated Animal Cruelty and Confinement to Motor Vehicle.





#### **Animal Rabies Testing**


There were 47 animals sent to an Illinois Department of Public Health (IDPH) lab and the University of Illinois for rabies testing. The animals tested were dogs (6), bats (21), cats (8) and (12) other small mammals.

Reasons for testing include a human bitten by an animal, a domestic animal exposure to a wild animal, or a human possibly exposed to a wild animal (primarily bats in homes).

#### **Kennel Visitors**

Sign-in records show that over 5,854 people visited the shelter kennel areas in 2024. Most of the visitors indicated they were looking for a pet to adopt or trying to find their missing pet.


#### Pet Registrations

In 2024, there were 44,419 tags sold within Winnebago County. 27% of the registrations were for cats and 73% were for dogs. Registrations were done at the shelter or area veterinary clinics.

Winnebago County pet owners are required to vaccinate and register all owned cats and dogs.

### Animals Impounded

During 2024, 5,683 animals were impounded. Of the 5,683 animals impounded, 37% were dogs, 50% cats, and 9% were wildlife. Other impounds (4%) were other pets, primarily rats, guinea pigs, domestic rabbits, and chickens.



There were 1,161 animals spayed or neutered in the shelter's surgical suite in 2024. Of the total spay/neuter surgeries, 305 were dogs and 856 were cats. Any dog or cat that is adopted or sent to a licensed rescue is spayed or neutered prior to leaving Animal Services. There were 54 other surgeries performed in the suite in 2024; the majority of these other surgeries were wound closures, growth removals, enucleations, and amputations.
